



## **VILLAGE OF CORRALES RESOLUTION NO. 13-019**

### **A Resolution Sponsoring, in Coordination with the Friends of the Corrales Library, a Father's Day Concert on June 16, 2013**

**Whereas**, a civic celebration popularly known as the Father's Day Concert was held beginning in June, 1979 and most of the years following until 1995; and

**Whereas**, the event featured prominent local, and sometimes nationally-known, musicians and musical groups, thus attracting audiences of Corralesños, guests and visitors from across the metropolitan area; and

**Whereas**, with affordable prices for tickets and beverages, proceeds were generated which provided substantial assistance to the construction and improvement of the Corrales Community Library; and

**Whereas**, the non-profit Friends of the Corrales Library wishes to resume the Father's Day Concert to pursue its ongoing contributions to the success of the Corrales Community Library and its programs; and

**Whereas**, the Village's La Entrada Park adjacent to the Library is an ideal venue for a resumption of the Father's Day Concert tradition; and

**Whereas**, the Governing Body of the Village of Corrales desires to co-sponsor the Father's Day Concert being planned for June 16, 2013; and

**Whereas**, if alcoholic beverages are to be served, the Friends of the Corrales Library agrees to obtain the relevant Special Dispenser's Permit from the New Mexico Alcohol and Gaming Division; and

**Whereas**, the Friends of the Corrales Library understands that the Village administration utilizes an Events Permitting Process for activities conducted on Village property and the Friends agrees to follow those procedures; and

**Whereas**, the non-municipal organizational and preparation expenses for the Father's Day Concert will be borne by the Friends of the Corrales Library and through contributions from interested citizens, not through budgeted expenditures

of the Village of Corrales, and the net proceeds will be received by and available to the non-profit Friends' for its programs; and

**Whereas**, the Friends of the Corrales Library have attended a Parks and Recreation Commission meeting and completed the Village's Event Permitting process,

**Now, therefore, be it resolved by the Governing Body of the Village of Corrales, New Mexico that:**

1. The Village of Corrales will co-sponsor with the Friends of the Corrales Library, a 501(c)(3) non-profit organization, a civic celebration on Sunday, June 16, 2013 to be known as the Father's Day Concert.
2. The Friends of the Corrales Library will abide by the Village's Events Permitting Process in planning and holding the Father's Day Concert and, if alcoholic beverages are to be served, will obtain the requisite approval from the New Mexico Alcohol and Gaming Division.
3. All non-municipal organizational and preparation expenses will be borne by, and all net proceeds from the Father's Day Concert will be paid to, the Friends of the Corrales Library.
