RESOLUTION NO. 14-06

A RESOLUTION PROVIDING FOR FIRE CHIEF'S SPECIAL PAY, PAYABLE TO VILLAGE FIREFIGHTER'S EMPLOYED FOR SPECIAL EVENTS, AND SPECIAL ASSIGNMENTS IN EXCESS OF USUAL STAFFING LEVELS; PROVIDING THAT FIRE CHIEF'S SPECIAL PAY SHALL BE PAYABLE FROM SPECIAL CONTRACTS, THE NEW MEXICO RESOURCE MOBILIZATION PLAN, OR GRANT FUNDS OF THE FIRE DEPARTMENT THAT ARE LEGALLY AVAILABLE FOR SUCH PAYMENTS OR REIMBURSABLE TO THE VILLAGE. ESTABLISHING PAY RATES FOR THE PAYMENT OF FIRE CHIEF'S SPECIAL PAY.

WHEREAS: the fire department participates in the State Resource Mobilization Plan, contracts with Energy, Minerals and Natural Resources Department, Forestry Division and with certain special events in the Village of Corrales the "Village", such as but not limited to the Harvest Festival and the Fourth of July parade, present an occasional and recurring need for the presence of firefighter in excess of usual staffing levels to provide; and

WHEREAS: the Village Council finds and determines that firefighter working hours for special events and activities, as authorized or required by the Fire Chief, should be fairly compensated for such time services at reasonable pay rates.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL, THE GOVERNING BODY OF THE VILLAGE OF CORRALES, THAT:

I. **Authorization:** The Fire Chief the "Chief" is authorized to provide for increased fire department staffing levels for special events and activities as deemed to be necessary and appropriate by the Chief, and to provide that firefighters working special pay hours to provide such staffing shall be paid for their special pay hours at the Fire Chief's Special pay rates hereinafter set forth. Fire Chief's Special pay for the Fire chief must be approved by the Village Administrator.


2. **Sources of Funding:** Chief's Special pay shall be payable solely from funds of the Fire Department that are legally available for such purpose, as determined by the Chief with the concurrence of the Village Administrator, and shall only be payable from the Village's general fund when contracts for reimbursement are in place.

3. **Rate of Pay:** Special pay rates as Chief's special pay in accordance with this Resolution shall be compensated at the following rates following the United States Forest Services Handbook, FSH 5109.34 Interagency Incident Business Management Handbook Chapter 10- Personnel, Interim Directive no. 5109.34-2013-1 Effective April3, 2013. At no time will a full-time employee with the Fire Department while working on a special assignment be paid less than their overtime rate with the Village of Corrales.


