RESOLUTION NO. 14-13

**A Resolution to permit priority use of La Entrada Park by the
Corrales Society of Artists for the monthly Art in the Park exhibitions and sales in 2014**

Whereas, the Corrales Society of Artists is a New Mexico non-profit corporation which promotes public awareness of the Corrales arts community and provides opportunities for its fine artists and artisans to exhibit and market their work; and

Whereas, in prior years the Society has organized monthly Art in the Park exhibitions and sales in La Entrada Park, owned by the Village of Corrales; and

Whereas, Art in the Park attracts visitors and shoppers to the Village, many of whom also visit the Sunday Growers Market at the Corrales Recreation Center and Sunday in Corrales, a marketing program of Corrales MainStreet for local galleries, shops, and restaurants; and

Whereas, Art in the Park will be held on the third Sunday of the months of May, June, July, August, and October, 2014, between the hours of 10am and 4pm; and

Whereas, the Art in the Park requests priority use of La Entrada Park, band shell; and

Whereas, the Corrales Society of Artists informs its members and participants in Art in the Park of their responsibilities to collect and report gross receipts taxes on sales to Corrales Locator number 29-504, and, where members operate a studio in the Village, the home occupation permit and business license requirements; and

Whereas, the Corrales Society of Artists will manage, pursuant to its rules and procedures, the selection of exhibitors, promotion, set up, take down, cleanup, provision of incidental refreshments, and other aspects of the Art in the Park activity; and

Whereas, the Corrales Society of Artists will not provide amplified music before 12 noon; and

Whereas, the Corrales Society of Artists has attended an administrative review meeting, as scheduled by the Village Clerk, with a completed Event Permit application, site plan, and summary.

NOW THEREFORE BE IT RESOLVED by the Governing Body of the Village of Corrales that the Corrales Society of Artists is authorized priority use, with rental charge of \$150.00 per event, of La Entrada Park on the third Sunday of the months of May, June, July, August, and October, 2014 for the Art in the Park exhibition and sales provided that it obtains a general liability insurance policy covering all Society activities in the Park, in an amount no less than two million dollars (\$2,000,000) aggregate and one million dollars (\$1,000,000) per event, and provides certification naming the Village of Corrales as an additional named insured on the policy.

BE IT FURTHER RESOLVED, The Corrales Society of Artists will ensure each vendor is informed that anyone participating in the 2014 Art in the Park must be registered to do business in the Village of Corrales.


