



**VILLAGE OF CORRALES
RESOLUTION NO. 15-11**

**A RESOLUTION REGARDING THE HOLIDAY ART FEST SHOW IN
THE RECREATIONAL SOCCER FIELD SPONSORED BY THE CORRALES SOCIETY OF
ARTISTS/ NEW MEXICO ARTISTS MARKET AND ESTABLISHING A FEE FOR USE OF
THE FACILITY**

WHEREAS, the Corrales Society of Artists /New Mexico Artists Market (CSA/NMAM), continuing its efforts to promote Corrales as an art venue, is planning to sponsor a Holiday Art Fest Show in the Corrales Recreational Soccer Field from November 27 – 29, 2015, and has requested:

- a. To use the Corrales Recreational Soccer Field for the purpose of an art show to display and sale of their art to conclude its 2015 Art Season,
- b. Access to, and use of, the electrical power source located on the soccer field for tent lights without charge,
- c. Use of Village parking areas located adjacent to the soccer field, and

WHEREAS, the CSA/NMAM has attended an administrative review meeting, as scheduled by the Village Clerk, with a completed Event Permit application, site plan, and summary; and

WHEREAS, the CSA/NMAM website www.corralesartistsmarket.org maintains contact information; and

WHEREAS, the event will take place in a heated tent November 27, 28 and 29, 2015 from 10am to 4pm; and

WHEREAS, the CSA/NMAM will provide a certificate of liability for this event naming, as additional insured, the Village of Corrales.


WHEREAS, the CSA/NMAM informs its members and participants in The Holiday Art Fest Show of their responsibilities to collect and report gross receipts taxes on sales to Corrales Locator number 29-504, and, where members operate a studio in the Village, the home occupation permit and business license requirements; and

NOW THEREFORE BE IT RESOLVED by the Governing Body of the Village of Corrales supports the Art Show in the Recreational Soccer Field sponsored by the CSA/NMAM and that the CSA/NMAM is authorized use, with rental charge of \$300 for the event, the Corrales Recreational Soccer Field from November 27 to November 29, 2015, for the Holiday Art Fest Show, provided that it obtains a general liability insurance policy and provides certification naming the Village of Corrales as an additional named insured on the policy.

BE IT FURTHER RESOLVED, The CSA/NMAM will inform each vendor that anyone participating in the 2015 Holiday Art Fest Show must be registered to do business in the Village of Corrales.
