



## VILLAGE OF CORRALES RESOLUTION NO. 15-37

**A Resolution granting temporary permit and waiving rental fees, for use of Village parks and parking lots for a concert in La Entrada Park, coordinated by 5 Cent Productions, which will benefit The Corrales Parks and Recreation Department and Corrales Library on September 19th, 2015.**

**Whereas**, the event will feature musical group The Noms, a group from Albuquerque, thus attracting an audience of Corraleños, guests and visitors from across the metropolitan area; and

**Whereas**, the Village's La Entrada Park adjacent to the Library is an ideal venue for the Benefit Concert and

**Whereas**, the Village's Parks and Recreation parking lots located at, 500 Jones Road, will be used for parking, along with administration parking lot at, 4324 Corrales Road , for handicapped parking during the event and

**Whereas**, 5 Cent Productions understands that the Village administration utilizes an event permitting process for activities conducted on village property and 5 Cent Productions agrees to follow those procedures; and

**Whereas**, 5 Cent Productions has attended a Parks and Recreation Commission meeting and completed the Village's event permitting process,

**Whereas**, the Administration and the Parks and Recreation Commission request that the Governing Body of the Village of Corrales agree to grant a temporary permit for this special event which is anticipating two hundred (200) or more participants.

**Whereas**, the Governing Body also agrees to waive rental fees for the Benefit concert as requested by the Parks and Recreation Commission for the concert being planned for September 19th, 2015; and

**Whereas**, the non-municipal organizational and preparation expenses for the Benefit Concert will be borne by 5 Cent Productions through ticket and merchandise sales, not through budgeted expenditures of the Village of Corrales.

**Now, therefore, be it resolved by the Governing Body of the Village of Corrales, New Mexico that:**


1. The Village of Corrales will grant a temporary permit and waive rental fees for 5 Cent Productions who is planning a Concert Saturday, September 19th, 2015 to be known as the Benefit Concert for Village of Corrales Parks and Recreation Department and The Corrales Library.
2. 5 Cent Productions will abide by the Village's Events Permitting Process in planning and holding the Benefit Concert.
3. 5 Cent productions will provide liability insurance.
4. All non-municipal organizational and preparation expenses will be borne by, 5 Cent Productions.
