**RESOLUTION NO. 17-023**

**A Resolution to permit use of the East Soccer Fields at the  
Corrales Recreation Center by the Corrales Society of Artists/New Mexico Artists  
Market for the monthly Art in the Park exhibitions and sales in 2017**

**Whereas**, the Corrales Society of Artists/ New Mexico Artists Market (CSA/NMAM) is a New Mexico non-profit corporation and a federal 501(c)(3) which promotes public awareness of the Corrales arts community and provides opportunities for its fine artists and artisans to exhibit and market their work; and

**Whereas**, Art in the Park attracts visitors and shoppers to the Village, many of whom also visit the Sunday Growers Market at the Corrales Recreation Center and Sunday in Corrales, a marketing program of Corrales MainStreet for local galleries, shops, and restaurants; and

**Whereas**, Art in the Park will be held on Sunday, on the following dates, August 6<sup>th</sup>, September 3<sup>rd</sup> and October 8<sup>th</sup>, 2017, between the hours of 9:00 am and 2:30 pm; and

**Whereas**, Art in the Park will be held at the East Soccer Fields of the Corrales Recreation Center which will place it in proximity to the Sunday Growers Market, encouraging visitors to one of those events to visit the other as well; and

**Whereas**, the Art in the Park requests use of the East Soccer Fields at the Corrales Recreation Center on the dates listed, with priority use of the East Soccer Fields and subject to a commitment to share parking and other facilities with other users, and also requests access to and use of an electrical power source without charge; and

**Whereas**, the CSA/NMAM informs its members and participants in Art in the Park of their responsibilities to collect and report gross receipts taxes on sales to Corrales Locator number 29-504, and, where members operate a studio in the Village, the home occupation permit and business license requirements; and

**Whereas**, the CSA/NMAM will manage, pursuant to its rules and procedures, the selection of exhibitors, promotion, set up, take down, cleanup, provision of incidental refreshments, and other aspects of the Art in the Park activity; and

**Whereas**, the CSA/NMAM will not provide or permit amplified music before 12 noon; and


**Whereas**, the CSA/NMAM has attended an administrative review meeting, as scheduled by the Village Clerk, with a completed Event Permit application, site plan, and summary.

**NOW THEREFORE BE IT RESOLVED** by the Governing Body of the Village of Corrales that the CSA/NMAM is authorized use, with rental charge of \$165.00 per event and the provision of electrical service at no additional charge, of the East Soccer Fields at the Corrales Recreation Center on the following dates, August 6<sup>th</sup>, September 3<sup>rd</sup> and October 8<sup>th</sup>, 2017, between the hours of 9:00 am and 2:30 pm; for the Art in the Park exhibition and sales; and provided that it obtains a general liability insurance policy covering all Society activities in the Corrales Recreation Center, in an amount no less than two million dollars (\$2,000,000) aggregate and one million dollars (\$1,000,000) per incident, and provides certification naming the Village of Corrales as an additional named insured on the policy.

**BE IT FURTHER RESOLVED**, CSA/NMAM will inform each vendor that anyone participating in the 2017 Art in the Park must be registered to do business in the Village of Corrales.


